NEW FOR 2022

ONTARIO SENIORS CARE AT HOME TAX CREDIT

All medical expenses are eligible - not just home care. Available to seniors age 70+ with family incomes under \$65,000. REFUNDABLE credit up to \$1,500 PER PERSON. If you haven't claimed your medical expenses before, now is the time!

Both of these credits have been doubled in 2022!

FIRST-TIME HOME BUYERS TAX CREDIT (HBTC)

If you bought a home for the first time in five years (or if you are disabled), you can receive a credit of up to \$1,500 per household.

HOME ACCESSIBILITY TAX CREDIT (HATC)

If you are a senior or disabled (or live with someone who is), you can receive up to \$3,000 on home improvements related to accessibility to and in the home.

UNDERUSED HOUSING TAX (UHT)

This new tax is could require you to file a separate return. The rules are complex – see our Rental Property Worksheet for more information.
